 - EVO and NCC reserve the right to discontinue the program at any time.

PROMOTION
 - Each Participant may earn a Promotion Bonus by submitting a merchant prospect that meets each of the following criteria during the Promotion Period:
 - Such merchant prospect cannot be a customer of EVO or any affiliate of EVO, and was not a customer of EVO or any affiliate of EVO during the past year.
 - Seasonal merchant prospects are not eligible for the promotion.
 - Merchant prospects with 4 or more locations will be assessed by EVO for eligibility on a case-by- case basis.
 - The merchant prospect must sign a Merchant Processing Agreement with EVO.
 - The Merchant Processing Agreement must have a minimum of a 3-year term.
 - EVO reserves the right to apply a minimum rate and volume requirements.
 - Merchants processing less than \$10,000 monthly are not guaranteed for the promotion and will be handled on a case by case basis and evaluated based on profitability.
